1. The remote e-voting period remained open from 27<sup>th</sup> September, 2021 (09:00 a.m.) and ends on 29<sup>th</sup> September, 2021 (05:00 p.m.).
2. The shareholders holding shares as on the "cut off" date i. e 23<sup>rd</sup> September, 2021 were entitled to vote on the proposed resolution (item no. 1 to 3) as set out in the notice of 29<sup>th</sup> Annual General Meeting of Company.



3. The votes were unblocked on 30<sup>th</sup> September, 2021 in presence of two witnesses, who are not in the employment of the company.
4. Thereafter, the details, containing, inter-alia, list of equity shareholders, who voted "For" and "Against", were downloaded from the e-voting website and total of Seven (7) members for 41,48,400 votes participated in e-voting process.
5. The total number of Ballots (Physical) received were 14 for 11, 100 votes.
